Explanation of Responses:

1. Represents (a) 17,377 shares of Class C common stock and (b) 48,454 unvested restricted stock units ("RSUs") as follows: (i) 3,381 unvested RSUs of an award granted on March 15, 2022, which vests in full on March 15, 2025, (ii) 9,775 unvested RSUs of an award granted on March 15, 2023, which vest in two equal installments on the second and third anniversaries of such grant date, (iii) 5,418 unvested RSUs of an award granted on March 15, 2024, which vests in three equal installments on the first, second and third anniversaries of such grant date, and (iv) 29,880 unvested RSUs of an award granted on June 15, 2023, which vests in installments of 20% on the first anniversary, 30% on the second anniversary and 50% on the third anniversary of the grant date of such award. The vesting of each of the foregoing installments is contingent on the reporting person's continued service on each applicable vesting date.


Limited Power of Attorney for Section 16 Reporting Obligations
